The AGM of Sepaktakraw federation of India was held at 01:00 pm on 30th MARCH 2022 at conference hall, SMS Indoor Stadium JAIPUR RAJASTHAN. The meeting was presided over by Shri S.R.Premraj president of Sepaktakraw federation of India. The following members were present:-

The meeting started with warm welcome by the president S.R.Premraj & on behalf of Rajasthan State Mr. T. K. Singh also welcomed all the members of general body.

President STFI informed the house that our Mr. Manoj Pattnaik Vice President STFI passed way in august 2021, so the condolence should be tribute by house members. The entire presented member stand up and took two minute silence in the memory of Mr. Manoj Pattnaik.

Then president requested the secretary general Mr. Veeregowda to conduct the proceedings as per agenda.

Secretary General starts the proceedings of AGM according to agenda as followings:-

1. The minutes of the last meeting held at Delhi on 29-11-2020 were read, the proposal to accept the same moved by Mr. Shivender Dubey and seconded by Mr Nagendra Sharma was unanimously accepted.
2. The report prepared by Secretary General for year 2020-21 was placed before the house where in he elaborated the activities and the achievements of the STFI throughout the year. The president & all members present in house satisfied the efforts taken by Secretary General for the development of game. The same was proposed for approval by P. N. Azad and seconded by G. Srinivasulu, and was accepted unanimously.
3. The financial year 2020-21 audit report given by Sandeep Gupta and Company was placed before the house. After going through the same, it was moved for acceptance by Mr. Kishore Kumar Treasurer seconded by Bhupinder Kumar was accepted unanimously.
4. President requested the members of the house to suggest different names for the same after collecting names by members the house again authorized Sandeep Gupta and Company to appoint the auditor for year 2021-22, then proposal was moved by Pruthiraj Sahu and seconded by D. Balamurugan and was accepted unanimously.


5. The President informs the house that today house should take the decision on CEO post after the denial of Mr. Dahiya. Further he stated that as per new circular of MYA&S GOI the guidelines also issued for CEO post and we having the amendments accordingly in Agenda 7 of today meeting. All members agreed unanimously that this should be covered during Agenda 7 as amendments in constitution and CEO post and Chairmen post to be deleted from STFI Constitution as per NSDC 2011 guidelines.
6. The President informs to house that in this agenda the national championships for 2022-23 sessions to be allotted. Mr. Veeregowda Secretary General informs that STFI received the applications form H.P., A.P., Delhi, Maharashtra, Uttarakhand, Telangana, Chandigarh, Karnataka, Jharkhand, Odisha, Bihar, Manipur, Kerala, West Bengal & Tamilnadu state association to organize the various national championships. The house discussed and decide that the power grants to President STFI after consulting with Secretary General to allot National Championships to best association whom able to host in good manner.
7. The new amendments draft in constitution of STFI as per compliance of National Sports Code 2011 which draft is already distribute with agenda was placed before the house. After going through the same, it was moved for acceptance by Mr. D. Balamurugan, seconded by Mr. T.K. Singh was accepted unanimously.
8. President STFI informed house that due to COVID-19 Pandemic all international championships are postponed or canceled by ISTAF & ASTAF till April 2021. STF have to organize international championship in India in 2021 so host city have to finalize with discussion with ISTAF. After healthy discussion among the member present in house and house agreed to send the names of GOA & CHENNAI cities names to ISTAF for final approval.
9. The President informs the house that today house should take the decision on Pujab, J & K and Andman & Nicobar Associations as per the application received from them to grant affiliation with STFI. The house discusses and decides that Sepaktakraw Association of Punjab submitted the all documents to STFI office along with registration certificate from societies of registration. House agreed to provide affiliation to Punjab with STFI. The association of Andman & Nicobar has not submitted all the necessary document and fees to STFI office with in a year time and request to provide more time of one year for session 2022-23 the provisional affiliation grants to Andman & Nicobar association. J & K association also grant one year provisional affiliation for submit the all necessary document and fees to STFI was accepted by house unanimously.
10. President informs the house that as per till today information the international competitions is Asian Games 2022 China in September and 35th Kings cup Thailand in July and our team is going to participate in both championships with the approval of GOI.

11. Any Other Matter with permission of chair:-

Mr. Pruthiraj Sahu request to house that the one award should be started on the name of Late Mr. Manoj Pattnaik for best discipline Team during National Championship. Mr. Ashok Kumar Sharma request to house that one more award should be started on the name of Late Mr. Sardari Lal Sharma for Best Referee. All Members agreed on both proposal and accepted by house unanimously.

Due to very long meeting for four hours and now it is times for Lunch, President STFI put humble request for not taking any more matter in other Agenda to finish the meeting. All the Members present in house accepted the request of President.

On behalf of Sepaktakraw Federation of India Mr. Veeregowda gave vote of Thanks to all members for attending the meeting at Jaipur and invited all member for the Lunch.

4. President requested the members of the house to suggest different names for the same after collecting names by members the house again authorized Sandeep Gupta and Company to appoint the auditor for year 2020-21, then proposal was moved by Naresh Kumar and seconded by D. Balamurugan and was accepted unanimously.
5. The President informs the house that today house should take the decision on Andman & Nicobar Associations as per the application received from them to grant affiliation with STFI. The house discuss and decide that The association of Andman & Nicobar have submitted all the necessary document and fees to STFI office with in a year time & till time of one year for session 2020-21 the provisional affiliation grants to Andman & Nicobar association . The



affiliation proposal of Andman & Nicobar association was proposed by the Veerégowda and seconded by Mr. Bimal Kanti Pal was accepted by house unanimously.

6. The President handed over the chairmanship to the Returning Officer Mr. Raghuvinder Verma to start the election proceeding of STFI Executive Body election for the Term of 2020-24. The R.O. inform the house that now all the proceedings of STFI election are complete and hence he has only received the nomination form same number as posts in STFI office bearers so no voting to be needed in this election.

Then meeting started with warm welcome by the President & on behalf of JHARKHAND State Mr. UDAY SAHU also welcomed all the members of general body. Then president requested the secretary general Mr. Dahiya to conduct the proceedings as per agenda.

President directed to Secretary General to starts the proceedings of AGM according to agenda.

1. The minutes of the last meeting held at JODHPUR on 05-01-2019 were read, the proposal to accept the same moved by Mr. Binal Kanti Pal and seconded by Mr Veeregowda was unanimously accepted.
2. The audit report given by Sandeep Gupta and Company for year 2018-19 was placed before the house. After going through the same, in absence of Treasurer, STFI it was moved for acceptance by Mr. S R Premraj and seconded by Mr. T.K.Singh was accepted unanimously.
3. President requested the members of the house to suggest different names for the same after collecting names by members the house again authorized Sandeep Gupta and Company to appoint the auditor for 2019-20 the proposal was moved by D. Balamurgan and seconded by Holshe Khrieo and was accepted unanimously.
4. The report prepared by Secretary General was placed before the house where in he elaborated the activities and the achievements of the STFI throughout the year 2018-19. The President & all members present in house satisfied the efforts taken by Secretary General for the development of game. The same was proposed for approval by G.Srinivasulu and seconded by Manoj Pattanaik , and was accepted unanimously.
5. The new amendments draft in constitution of STFI which draft is already sent in advance with agenda was placed before the house. After going through the same, it was moved for acceptance



by Mr. D. Balamurugan Joint Secretary seconded by Mr. Bhupinder Singh was accepted unanimously.

6. President STFI direct the members states to put their annual reports for the year 2018-19. The annual report for various states association submitted on the floor of house one by one from representatives of states associations was accepted unanimously.
7. President STFI inform the members that the tenure of AMSTA office bearers for year 2014-18 already finished and they failed to conduct new election for tenure 2018-22. AMSTA members fighting each others and complaints to Registrar office and registrar issue a letter to AMSTA regarding all activities should stopped. Regarding that some petitions also field by two groups and pending for decision in Manipur High Court. President further inform to house that after all Manipur High Court make a arrangement with form a committee to send the team of Manipur and here that committee send the Manipur team. STFI nothing related to this matter and as per High Court decision STFI follow up the matter in future.
8. The Secretary General informed the house with a request that as all of you known that the MYA&S/SAI make mandatory of PFMS system for providing the Grant in Aid as per direction received from Ministry of Finance Government of India. So STFI also started same PFMS system to receive or send the Grant In AID regarding National or International championships.
9. President inform the House that Karnataka, Delhi, Odisha, A.P. & Kerala states are interested to host the National Championship for year 2020-21. After discussion among the members House unanimously allotted the 24th Junior National to Karnataka, 23rd Sub- Junior National to Delhi & 31st Senior National to Kerala.
10. President informed the house that Himachal Pradesh & J & K we form new associations as provisional basis and now for grant them affiliation with STFI is proposed in Agenda so I proposed to grant the affiliation for Himachal Amateur Sepaktakraw Sports Association & Amateur Sepaktakraw Association of J & K as new members. All the members present in house unanimously agreed to grants the affiliation which is proposed by President STFI.
11. President STFI informs the house that Sepaktakraw is including again in National Games by IOA. He also inform that Mr. Chandrakant Kavlekar Deputy President STFI also take initiative and talk to Mr. Batra President IOA regularly for inclusion of Sepaktakraw in Goa National Games & we thanks to Mr. Kavlekar for his efforts.
12. President request to house that please suggest the Venue of next Elections of STFI for term 2020-2024. President informs to the house that as all knows that we are having the elections of STFI for the Term 2020-24 in July. The all members have to clear their dues regarding annual affiliation fees and other financial matters before 31st March 2020 to took part in election for the Term 2020-24. All members agreed and approve the implementation of due clear before 31st March 2020. Further President STFI inform the 36th National Games & World Championship also in the same year, so some problem may be for smooth running of STFI activities due to handing Taking over issue after elections as routine issues. He proposed a suggestion with



request to all members if all accept it we can conduct the election in November after National Games and World Championship at GOA, If the National Games postpone again from due dates then we conduct the election in July 2020. All the members present in house agreed unanimously to president proposal and approve the proposal.

13. Any Other matter with permission of chair:-

After that president not allow any member to raise any other matter due to shortage of time and lunch already delayed one hour after proposed schedule.
